Data protection policy and cookie policy

Data protection policy

This website complies with the obligations set forth in the Italian (legislative decree 101/2018 code relating to the protection of personal data) and EU (European regulation for the protection of personal data no. 679/2016, GDPR) regulations, and as amended.

In accordance with the recommendations from the Data Protection Authority on the GDPR adaptation, the controller of the website places a great deal of importance on the confidentiality of visitors and users in order not to harm their respective rights when they use this website. The aim of this data protection policy is to provide transparency and clear information with regard to the information collected on this website and its subsequent use.

This policy applies exclusively to the online functions of the website and is valid for the website's visitors/users. The policy does not apply to information that is collected outside the web channel in which this website is located.

Legal basis of the processing

From the date of the entry into force of the GDPR (25 May 2018), the website www.savercompositi.com will collect and process certain data on the basis of the interests of the data controller.

The current website processes data acquired on the basis of optional consent expressed by visitors/users: consent is only approved with the procedures and for the purposes described in the following paragraph.

Visitors/users can deny their consent for the provision and collection of data.

Refusing consent, through the specific refusal button on the banner of the cookies, or through a revocation of consent by email, could result in access to certain services being blocked and may compromise the browsing experience on this website.

Data collected and purposes

Data acquired from the system and security logs

During visits by users this website automatically acquires information through the system <u>LOG</u> and the security log.

The following information may be collected:

- time and date of the visit;
- IP address and name of the network provider;
- records of any errors and problems.

All these data will be collected in an aggregate form and will only be used to support diagnostics for security purposes. e.g. in the event of an attack logs will be monitored to block unauthorised access and prevent harmful activities.

These data may only be accessed by server administrators and are never used to identify or profile users/visitors as they are only acquired to protect the security of this website. The data may be used only in the event of a crime and at the request of judicial authorities in cases established by the law.

Log data collected by the website are processed in the registered offices of the Data Controller and in the web host's data centre.

The web host is responsible for the processing of data (Ekados s.r.l - Via Costantino Baroni 192A, 20142 Milano) and only processes data at the express request of the controller and acts in compliance with European regulations.

Data used for security purposes are retained for 90 days.

Cookies

This website uses cookies, small files that are memorised on the computer of users and which make it possible to acquire/retain information on the preferences of users for the purpose of:

- improving the functions of this website;
- simplifying browsing through automated procedures (e.g. logins, choice of website language)
- analysing use of the website to improve usability and the user experience.

Session cookies are necessary for differentiating between users connected to the website and for avoiding functions requested by one visitor from being used by another visitor, and are necessary for security purposes to try to neutralise cyber attacks on the website.

The session cookies used on this website do not acquire personal data and their duration is linked to the browsing session. Session cookies are deleted when the browser is closed. Session cookies do not require the consent of the user.

Functionality cookies used by this website are essential for using the website and are associated to functions that are specifically requested by visitors (e.g. a login to a reserved area, or the acceptance of the warning banner on cookies). Session cookies do not require the consent of the user.

Disabling cookies

Refusal of the acceptance of the initial banner will result in the installation of cookies being blocked.

In any case, cookies are strictly connected to the visitor's browser and cookie management, as well as the revocation of cookies that were previously accepted, can take place through the browser.

Third-party cookies

This website acts as an **intermediary in terms of third-party cookies** and has no control over these cookies. These cookies are used for:

- Acquiring statistical information on the use of the website (Google Analytics)
- adding certain external functions to the website (Google Maps)

In particular **Google Analytics** data are acquired through a code inserted on the website which is preset so that IP addresses are anonymised.

These anonymous data (e.g. number of visits, list of the most frequently visited pages, average browsing time) that are collected in an aggregate form through an Administration panel are used by the website analysts, following an express request by the controller, to devise new functions for the website and improve browsing and the user experience.

Data are transmitted to and deposited on Google's servers in the United States and are retained for a period of 26 months.

Transfer of data to non-EU countries

The controller is currently required to accept the policies used by third parties (Google, Facebook and Microsoft) with regard to the transfer of data to Third Countries so that it can provide users of the website with these third parties' respective services.

Security measures

The processing of data required from users through this website is managed lawfully by adopting all the appropriate measures for:

- improving security
- preventing unauthorised access
- preventing the unauthorised disclosure of data.

Processing is carried out using electronic devices, with criteria and organisational procedures that are strictly connected to the purposes described above. Aside from the controller, access to the data is delegated to technical consultants involved in the website project, e.g. Google Analytics. Parties involved, all of whom are appointed by the data controller, can also be external to the company and are understood to be third party providers of technical services, hosting providers, IT companies, web marketing agencies.

Rights of users

Pursuant to European regulation 679/2016 (GDPR), and in accordance with the procedures and limits set forth by the prevailing regulation, visitors/users can exercise the following rights:

Right to withdraw, or update/amend/supplement and erase data;

request confirmation of the existence of their personal data;

request the origin of their data in an intelligible manner;

have information on the data processing procedures and purposes;

request that data is transformed into an anonymous form

Present a complaint to the Italian Data Protection Authority, in its capacity as supervisory authority (link to the Italian Data Protection Authority website);

Requests must be sent to the data controller using the 'contact us' form.
